# **Privacy Policy**

This Privacy Policy ("Policy") applies to www.drmariane.com, and Healing 2 Thrive LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.drmariane.com. The Company's website is a Health and Wellness site. By using the Company website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
